### Int'l Melanoma Working Group (IMWG) Research Update

As 2013 comes to an end, everyone in the melanoma world can be thankful for the new drugs that have been approved and for more approvals that are on the horizon. Patients are becoming survivors, and those survivors are living longer and better lives.

We applaud the efforts of all of those involved, but we are acutely aware of the fact that we still have a long way to go. There are still far too many questions unanswered...

- *Who is susceptible to getting melanoma?*
- *Whose melanoma will spread?*
- *Which treatments work best on which patients?*
- *How can we best prevent or treat brain metastases?*

Our IMWG is looking for answers to these questions through its many research efforts. We have...

- *launched the first of its kind clinical trial with patients who have operable brain metastases,*
- *opened a brain metastases tissue bank that enables researchers to study brain metastases first-hand, and*
- *established our first primary melanoma tissue bank site that will open in 2014.*

Our IMWG is looking to create and run a whole new kind of clinical trial system that will bring us the answers we need more quickly, while using far fewer patients.

Many institutions and researchers worldwide have expressed their support for our endeavors and asked that they be included as these projects grow. ***In order to do this, we need your support!***

### AIM Awards \$74,450 in Research Grants to MD Anderson Cancer Center (MDACC)



### **UPDATE - California's Indoor Tanning Statute**

As of January 1, 2014, it will be 2 years since California's law to protect minors under the age of 18 from indoor tanning devices went into effect. In a recent study, researchers from UCSF found that the majority of California salons are complying with the law, which suggests that laws to ban indoor tanning for minors under 18 have an impact.

Unfortunately, most of the facilities in this study denied any dangers from ultraviolet tanning and made unlawful claims of health benefits from indoor tanning. **AIM believes additional enforcement is required to ensure accurate disclosure of the dangers of indoor tanning devices and to prevent unproven claims of health benefits.**

Currently, only five states completely prohibit minors under 18 from using commercial indoor tanning devices. **AIM will continue its effort to pass similar legislation throughout the country.**

### **UPDATE - Oral Chemo Legislation**

As of January 1, 2014, 27 states will have enacted oral chemotherapy access laws. In 2013 alone, seven states passed legislation. **AIM thanks ALL who supported this effort in 2013.**

However, there are 23 states where cancer patients still face choosing an intravenous or injected anti-cancer medication that may be less effective over an oral treatment simply because the intravenous or injected anti-cancer medication is less expensive under their health insurance plan.

AIM does not believe that patients should have to choose a treatment based on financial obligations. Therefore, AIM has joined forces with a number of other organizations to support oral chemo legislation, including US House Bill 1801.
